COMMISSION REPORTS

Mayor Armstrong

Mayor Armstrong reviewed with the Commission and residents the past six-years as Commissioner and Mayor of the Town of Redington Shores. Projects completed – completion of Del Bello Park, 50th Anniversary events, annexation of the Parsley Property, beach access improvements and walkovers, continuation of Stormwater and Paving Projects, completion of the EAR and amendments to the Comprehensive Plan, Gulf Beaches Library negotiations, FDOT Palm Tree Grant Project, Undergrounding Utilities, Turtle Ordinance, Re-Entry Hang Tag Program, etc. Mayor Armstrong thanked each of the Commissioners for rising to the challenge and actively embracing their areas of responsibility. Mayor Armstrong thanked all the citizens stating "it has been my highest honor to serve you". Advice to the incoming Commission, please be proactive to preserve the town, protect the beaches, deny construction or redevelopment variance request that would bring structures closer to coastal construction line than permitted by code, most important, read and follow the town's Comprehensive Plan, it is the road map to the future. Mayor Armstrong wished the Commission good luck and best wishes.

Vice Mayor Adams, Commissioner District No 1

Indian Shores Police Department – criminal and traffic citations, traffic warnings are up. Other calls with no reports were up. Vice Mayor Adams reported 14 unlocked cars have been burglarized and encourage all to lock their vehicles.

Vice Mayor Adams reported that Station 26 for emergency services will be closed in October due to budget cuts in Pinellas County. Emergency response will be provided from Seminole. Vice Mayor Adams encouraged the residents to attend a meeting on March 20, 2009 at 9:00 a.m., at the County Commission Chambers to support keeping the station open.

Commissioner Branch, Commissioner District No 2

Commissioner Branch thanked Mayor Armstrong and Commission Holthaus for what they have done for the town and expressed he has enjoyed working with them. Commissioner Branch expressed condolences on behalf of the Commission to Attorney Denhardt for the loss of his father-in-law.

The lift station alarm at 176th Ave. and First Street East has been repaired. The stormwater project is moving along, any issues that come up are taken care of immediately.

Commissioner Wojcik, Commissioner District No 3

Flood Plain Management Plan – the committee has finished drafting the plan. The plan will be distributed to the Commission for approval at the April Commission meeting.

LMS – the town submitted two projects for funding, undergrounding the utility lines across Gulf Boulevard and two new crosswalks. The Gulf Boulevard project was rejected, but the crosswalks are being considered.

Gulf Beaches Library – the second annual Food For Thought Fund Raiser was a great success. Total monies made will be available after March 18th.

Emergency Management – Pinellas County has scheduled the first meeting for all municipalities on March 20th.

Del Bello Park – dead trees have been removed. One of the osprey nests has a family nesting.
