Commissioner Kapper, Commissioner District No1

Del Bello Park – mangroves will be planted and a rail installed at the new kayak launch.

Commissioner Wojcik, Commissioner District No 3

Flood Plain Management Plan – Commissioner Wojcik thanked those involved with the plan. The plan has been updated and will be approved at tonight's meeting.

Emergency Management – several staff and officials attended the Barrier Island Summit, participating in discussions on how local governments can prepare for response and recovery from a hurricane. The town's Hurricane Awareness Meeting will be scheduled for the end of May.

Access Channel – the equipment is up and running. Live streaming the Commission meetings is in the process.

Commissioner Holmes, Commissioner District No 4

Building Department – 62 permits where issued in April 2013, with a revenue of \$29,071.00. One permit was for a new home.

Fire Services – two non emergency response with an average response time of eight minutes fourteen seconds and five emergency responses with an average response time of six minutes twenty two seconds.

Emergency Medical Services – twenty three emergency responses with an average response time of five minutes fifty three seconds and five non emergency responses with an average response time of seven minutes and thirty six seconds.

Mayor Adams mentioned there were residents in the audience with concerns of items being set up on the streets for skateboarding, which is causing damages to personal and town property. Commissioner Holmes stated he actually did witness these actions, police were called and the situation is being handled. Mayor Adams stated Attorney Denhardt is reviewing a few ordinances to eliminate skateboarding in certain areas. This item will be on the next workshop agenda.
