## \*OPEN PUBLIC HEARING\*

First Reading – Ordinance 13-04 – Use of Skateboards, Roller Skates, and In-Line Skates in CTF Areas Attorney Denhardt read Ordinance 13-04 by title. Commissioner Kapper moved to adopt Ordinance 13-04 on first reading; seconded by Vice Mayor Branch. Commissioner Wojcik asked how the Town could help the kids, and provide a total solution, not a one-sided event. Commissioner Kapper said that banning skateboarding totally is not good, but more time is needed. Mayor Adams stated that the Town is going forward with the Ordinance to protect property and the kids. Attorney Denhardt advised that the Ordinance doesn't ban skateboarding except for the CTF public property. Josh Ross, owner of the Shoreline Skate Shop, spoke about the new park being built in Largo, and asked the Commission to find monies and a location in Town to build one. Mayor Adams called for roll call: Commissioner Wojcik no; Commissioner Kapper yes; Vice Mayor Branch yes; Mayor Adams yes.
