Vice Mayor Adams, Commissioner District No 1

Commissioner Branch, Commissioner District No 2

First Reading – Ordinance 08-08 – Gated Communities Emergency Access

Attorney Denhardt read Ordinance 08-08 by title. Vice Mayor Adams asked if the ordinance includes gaining entry into locked buildings. Attorney Denhardt stated it does have that provision. Vice Mayor Adams moved to approve Ordinance 08-08 on first reading, seconded by Commissioner Branch. Commissioner Wojcik asked if there were provisions for penalties for non compliance. Attorney Denhardt stated penalties would fall under the General Penalties of the Code and also Special Master. Roll call on the motion and second. All yes.

First Reading – Ordinance 08-07; Amending Parking Fines

Attorney Denhardt read Ordinance 08-07 by title. Vice Mayor Adams moved to adopt Ordinance 08-07 on First Reading, seconded by Commissioner Holthaus. Mayor Armstrong stated that during the workshop meeting she objected to a couple parts of this ordinance, while it is Florida Law, does not mean it is always a good law. second reading, seconded by Commissioner Holthaus. Roll call: all yes.

Resolution 13-08 FY 07/08 Budget Amendments

Vice Mayor Adams moved to adopt Resolution 13-08 for FY 07/08 budget amendments, seconded by Commissioner Holthaus. Roll call: all yes. Commissioner Wojcik stated it is important to note that there was an \$80,000.00 shortfall in revenue in the building department due to the economy.
