BOARD OF COMMISSIONERS TOWN OF REDINGTON SHORES WORKSHOP MEETING WEDNESDAY, MARCH 29, 2017 – 7:00 P.M. MINUTES

Present upon roll call: Commissioner Henderson, Commissioner Drumm, Commissioner Neal, Vice Mayor Kapper and Mayor Adams

OLD BUSINESS

<u>Discussion – Traffic Control</u> – 175th Ave. E.

Mayor Adams asked Vice Mayor Kapper to talk about the speeding issues on 175th Ave. E. Vice Mayor Kapper stated that for several years there has been speeding issues on 175th Ave. E. and speed controls should be installed. Mayor Adams explained that the town would like to install speed tables, versus the more aggressive speed bumps, on 175th Ave. E. Commissioner Henderson asked what Police Chief Hughes thought of installing the speed tables and Chief Hughes stated that if the tables were like what the Town of North Redington Beach installed on 173rd Ave., he thought it would be a good idea. Commissioner Neal stated that 60% of the people in the 175th Ave. district did not want the speed tables. Commissioner Neal asked that the speed limit be enforced by giving out tickets. Mayor Adams explained that it was not possible to have 24-hour surveillance on the street and if the speed tables saved one life, then it would be worth putting the tables down. Chief Hughes explained that during the research there were people driving up to 60mph. Several residents spoke against the placement of the speed tables. Mayor Adams suggested that the residents against the speed tables take a ride down 173rd Ave. in North Redington Beach to check out the speed tables. When asked if the town would put the speed tables on other streets, Mayor Adams explained that he couldn't foresee the future, but it could be possible if speeding issues elevated on another street. Mayor Adams stated that he would like to have a vote on the speed tables at the next regular meeting.

NEW BUSINESS

Discussion- Changing Meeting Times

Mayor Adams asked the Commission about changing the commissioner's meeting times to 6:00pm and they all agreed it would be okay. The mayor stated that there would be a resolution presented at the next regular meeting to vote on the new time.

Discussion - Review Police Budget - FY 2017/18

Police Chief Hughes went through and explained the budget to the commissioners. Mayor Adams stated that the budget would be on the agenda of the next regular meeting for the commissioners to vote on.

Discussion – Security Cameras – Town Hall

Commissioner Henderson asked the commissioners if they would be against putting cameras in the Town Hall. All of the Commissioners agreed that it would be a good idea and that the cameras should be HD quality. Commissioner Henderson stated that she would do some research and get back to them.
