PLEDGE OF ALLEGIANCE

### **OLD BUSINESS**

Discussion – No Wake Zone in Cove by Sea Breeze

Mayor Henderson states the No Wake Zone cannot be pursued based on safety as there have been no accidents reported in the past 5 years. The only avenue would be wildlife/manatees. By a show of hands 5 residents were for the cove being No Wake and 10 against. Three residents spoke for the No Wake, 4 residents spoke against. One resident provided the commission research from the Florida Fish & Wildlife showing no evidence of manatee deaths in the cove since 1971. Commissioner Drumm requests the No Wake Zone be addressed at the next Workshop meeting.

## Discussion Town Parking Lot – 178<sup>th</sup> Ave. West and Gulf Blvd., - Parking by Permit

Commissioner Neal suggests raising parking fines from \$25 to \$50. Commissioner Neal suggests simple signs to be placed in the parking lot limiting the size of the vehicle being parked in the lot. Commissioner Drumm suggests placing a meter in the lot for non-residents, increasing town revenue. Residents would be able to park for free with a permit. Mayor Henderson requests the subject to be placed on next Commission meeting agenda.

# **NEW BUSINESS**

Discussion – Code Enforcement Services

Commissioner Neal proposes to use the Pinellas County Sheriff's Office as the Redington Shores code enforcement. Chief Hughes states Indian Shores Police Department is the Redington Shores code enforcement. Chief Hughes proposed to have 2 officer's certified at the cost of \$1,700 per officer. Indian Shores will pay for one and Chief Hughes requests Redington Shores pay for the other. Commissioner Drumm suggests the Sheriff's Office be contracted for code enforcement on a trial basis until Indian Shores officers are certified. Consenus of commissioners agree.
