Present upon roll call: Commissioner Drumm, Commissioner Robinson, Commissioner Neal, Vice Mayor Kapper, Mayor Henderson and Attorney Denhardt.

Vice Mayor Kapper asked for all to bow their heads in prayer for the passing of the former Commissioner and Vice Mayor John Branch.

<u>APPROVAL OF MINUTES – Regular Meeting, March 13, 2019, Workshop Meeting, March 27, 2019</u> Vice Mayor Kapper moved to approve the minutes as stated, seconded by Commissioner Neal. Roll call: all yes.

### RATIFICATION OF BILLS - March/April 2019

Vice Mayor Kapper moved to ratify the bills as presented, seconded by Commissioner Robinson. Roll call: all yes.

### **COMMISSION REPORTS**

#### Mayor Henderson

Undergrounding - is moving along and is ahead of schedule.

Movie Night – the first ever Movie Night is Redington Shores was a great success and enjoyed by over 100 attendees. More movie nights will be held in the future.

Fire/EMS – Assistant Chief Morelli gave the following report for the month of March 2019.

Fire – there were three non-emergencies with an average response time of eight-minutes and thirty-seven seconds and three emergencies with an average response time of seven-minutes and one-second.

EMS – there were three non-emergencies with an average response time of three-minutes and forty-five seconds and seventeen emergencies with an average response time of five-minutes and eighteen seconds.

Indian Shores P.D. – Chief Swann reported calls for service were slightly up. Action reports were down. An arrest has been made in the home invasion.

<u>Vice Mayor Kapper, Commissioner District No 1</u> Building Department – eighty-one permits were issued in March with a total income of \$16,437.60

#### Commissioner Neal, Commissioner District No 2

Sewers – relining is continuing 180<sup>th</sup> Ave. and 182<sup>nd</sup> Ave. The company is moving forward with the laterals on the West side of Gulf Blvd.

Code Enforcement - January 4, 2019 – April 9, 2019 – a total of forty-five cases were handled and one Special Magistrate Hearing and one County Ordinance Court appearance.

Commissioner Neal stated the two roofs on the pavilions at Del Bello Park need repair. Two bids have been obtained; Dan McCullers Inc., \$4,400.00 (using stainless steel nails) and Super Roofs, \$4,250.00. Commissioner Neal stated also needed is to replace the facia board and paint, so the amount will increase about \$1,000.00. Vice Mayor Kapper moved to hire Dan McCullers for \$4,400.00 and adding additional monies for the facias repair, seconded by Commissioner Drumm. Commissioner Robinson asked where in the budget

would the money be coming from. The money would be appropriated out of Parks General Maintenance. Roll call on motion and second. All yes.

### Commissioner Robinson, Commissioner District No 3

Commissioner Robinson reported he attended a summit on March 28<sup>th</sup> about Red Tide. The panel consisted of scientist, researches and elected officials. This was a very informative session and encourages all to watch on You Tube.

Commissioner Robinson reported that Pinellas County will be doing routine maintenance on the water April 22<sup>nd</sup> through May 11, 2019. More information has been provided on the town's website.

CRS - Commissioner Robinson summarized a letter to the town from FEMA. The town through hard work and determination has received a Class 6 in the CRS program giving all residents a 20% discount on their Flood Insurance for NFIP policies issued or renewed on or after May 1, 2019. Commissioner Robinson congratulated all those involved for reaching this goal for the town residents.

### Commissioner Drumm, Commissioner District No 4

Commissioner Drumm reported the material for the Speed Bumps has arrived and installation will begin in the very near future.

The Wapro Valves have been ordered for installation on 182<sup>nd</sup> Ave. and 180<sup>th</sup> Ave.

Gulf Beach Library – Planning for the Food for Thought Fundraiser in 2020 is now underway. Many volunteers are needed, if you can spare your time please reach out to Town Hall.
