#### **OLD BUSINESS**

1. Second Reading of Ordinance 23-10- Revising Chapter 90 of the Town Code (The Land Development Code)- Mayor Commissioner Henderson introduced the item. Luis Serna, Consultant from Calvin, Giordano & Associates, discussed the changes made from the Regular Commission meeting on 9-13-2023. Mr. Serna stated that he revised the definition of "Artwork", added a placeholder for the Yacht and Tennis Club Ordinance 05-05, added "Vehicle Signs" to Sec. 90-179, revised the definition of "Balcony", removed "Boarding House", revised definition of "Building Official", revised definition of "Driveway", removed duplicate definitions of "Lot Width and Lot Depth", revised fence regulations in Sec. 90-159 (J) 6, and deleted Sec. 90-240. Mr. Serna acknowledged the change missed in Sec. 90-159 (I). Commissioner Herig spoke and suggested the addition to add "or equipment associated with new construction or substantial improvements". Attorney Eschenfelder spoke on the written comments received from resident Lisa Foster, 845 180<sup>th</sup> Ave E. Mr. Serna responded to the comments regarding Sec. 90-73 (B) (9) and did not recommend that it be removed to the Land Development Code. The Commission discussed Sec. 90-159 (I) 7 and Sec. 90-159 (K). Mr. Serna agreed with the additions suggested from the written testimony from Lisa. Foster. Commissioner Herig agreed with these changes. Mr. Serna recommended that the Commission adopt the Land Development Code with changes from the Regular Meeting on 9-13-23, the revision in Sec. 90-159 (I) 1, revisions in Sec. 90-159 (I) 7, and Sec. 90-159 (K). Attorney Eschenfelder spoke. Mr. Serna agreed to remove "retaining walls" from Sec. 90-159 (K). Commissioner Herig motioned to adopt Ordinance 23-10 with changes from the Regular Meeting on 9-13-23, the revision in Sec. 90-159 (I) 1, revisions in Sec. 90-159 (I) 7, and Sec. 90-159 (K). Vice Mayor Commissioner Hendrickson read Ordinance 23-10 by title. Hendrickson 2<sup>nd</sup>. Commission discussion. Vice Mayor Commissioner Hendrickson spoke on Sec. 90-73 (B) 9. Mr. Serna spoke. Commissioner Herig spoke. Mr. Serna spoke on adding consistency with County wide rules. Public Comment:
