### PRESERVING OUR "NATURE'S BEACH" AND ITS WILDLIFE

As the warmer months approach, coastal communities around the world prepare for an annual event that draws attention not only to the breathtaking beauty of nature but also to the responsibilities we bear as stewards of our wildlife environment. Turtle season and bird breeding, often spanning from spring to summer, mark the time when sea turtles return to their nesting grounds to lay eggs, and native birds arrive to re-nest; igniting a chain of events that captivates hearts and minds while stressing the importance of conservation efforts.

One of the key practices during nesting season revolves around the careful monitoring and protection of sea turtle nests and native bird colonies. Female turtles, driven by instinct and ancient patterns, crawl



ashore to find suitable spots to lay their eggs. These nests, typically dug in the sand, become delicate incubators for new life. Successful black skimmer colonies will usually occupy the same nest sites each year. However, the very beaches they rely on for nesting are also frequented by human

visitors, leading to potential conflicts and disturbances.

During nesting season, beachgoers digging holes pose risks to turtles and hatchlings. Unfilled holes can trap turtles, hindering their journey, while hatchlings can become stuck, vulnerable to predators. To address this, fill holes daily. Beach cleanliness is crucial too, as litter harms marine life. Cleanup initiatives, from organized events to individual efforts, are vital. Educational campaigns raise awareness and promote responsible waste management. Additionally, changing our light bulbs and installing wildlife friendly lighting helps avoid hatchling disorientation. Together, we can protect our marine ecosystems and vulnerable species, fostering environmental consciousness and stewardship.

As we embrace nesting season and the awe-inspiring spectacle of nature it brings, let us also embrace our role as custodians of the marine environment. By filling holes,

picking up trash, adjusting our light sources, and advocating for sustainable practices, we honor the ancient journey of sea turtles, birds, and other wildlife and



ensure that future generations can continue to marvel at the wonders of our "Nature's Beach."

#### REUSE, REDUCE, AND RECYCLE

Article collaboration with Christy Herig Pinellas County is steadfast in its commitment to achieve "Zero Waste to Landfill by 2050". This ambitious vision emphasizes the County's dedication to environmental sustainability and responsible waste management.

In the year 2022 alone, a remarkable 293 million pounds of recyclables were successfully transformed into new products, marking a significant stride towards this overarching goal. This achievement builds upon a legacy that traces back to the 1960s when fishermen initiated the construction of artificial reefs. However, it wasn't until 1975 that Pinellas County Solid Waste embarked on the creation of artificial reefs using clean, inert debris, particularly concrete. Over the years, approximately 50,000 tons of material have been deployed to foster these vital marine ecosystems.

Annually, the County collaborates with the *Tampa Bay Times* to ensure the Recycle Guide remains up-todate, serving as an indispensable resource for residents. A key reminder emphasized in this guide is the importance of refraining from bagging recyclables. This precaution is vital as plastic bags pose a significant hazard to recycling machinery and personnel. Instead, all recyclable items should be clean, dry, and larger than a hockey puck.

Items suitable for recycling include glass, plastic (ranging from #1 to #7), metal food cans, cartons (excluding plastic caps), dry unshredded paper, and broken-down cardboard boxes. Conversely, materials such as clothing, yard waste, foam packaging products, food waste or residue, paper towels, tissues, napkins, wires, cords, or hoses do not belong in the recycling bin.

In a bid to facilitate community participation,

Redington Shores Town Hall has been designated as one of the drop-off locations for recyclables within Pinellas County. Residents can easily locate the big, prominent recyclables container situated in the northeast corner of the Town Hall parking lot to conveniently drop off their recyclables. By spreading awareness and



actively engaging in responsible waste disposal practices, individuals can play a pivotal role in realizing the County's vision of a sustainable future. Most instrumental in my journey is my dear, dear friend and our previous Mayor, Bert Adams. If you knew Bert, you loved him – he was a cherished friend to many people and will forever be a part of our Town. Bert was the Mayor of Redington Shores for 10 years; he passed away on March 13th, 2022. I miss him and I honor his legacy every day.

"There are only two ways to live your life. One is as though nothing is a miracle. The other is as though everything is a miracle." ... The latter part of this Albert Einstein quote certainly applies to life in our amazing Town! Redington Shores is not only "our" home, but home to an abundance of the "miracle" of wildlife - Dolphins, manatees, sea turtles, otters, osprey, eagles, black skimmers, cormorants, anhingas, and more fish, birds, and butterflies than we can name - also call our Town home. Thankfully, the miracle of "wildlife" loves our "Coastal Strand" ecosystem, made up of natural water and terrestrial habitats across our beaches and Intracoastal Waterways (ICW). Many efforts are underway in RS to protect our natural habitats, while also beautifying our Town. The RS Parks and Recreation Committee is implementing Florida Friendly Landscaping<sup>™</sup> (FFL) practices to conserve our natural resources and enhance our parks and green spaces. There are 9 Principals of FFL: 1) Right Plant Right Place 2) Water Efficiently 3) Fertilize Appropriately 4) Mulch 5) Attract Wildlife 6) Manage Yard Pests Responsibly 7) Recycle Yard Waste 8) Reduce Stormwater Runoff and 9) Protect the Waterfront. Any residents interested in learning more about the FFL program and how you can implement these practices in your own yard, please contact me or Town Hall for more information. And please stay tuned, as new landscaping and improvements are being made throughout our public spaces, including potentially our new slogan, "Nature's Beach".

"Never, never be afraid to do what is right, especially if the well-being of a person or animal is at stake" ... This quote by Martin Luther King, Jr. is demonstrative of a brave and sensible initiative that the Town Commission has taken under consideration to protect the safety of our residents and visitors, as well as our precious wildlife. Resolution 07-2024 (which the RS Commission is currently considering) requests the Florida Fish and Wildlife Conservation Commission (FWC) to approve "the establishment of a Bird Sanctuary within the jurisdictional boundaries of the Town". This "Bird Sanctuary" initiative is a result of an occurrence of (legal) waterfowl hunting earlier this year (off the coast of District 2), which truly shocked the residents. No one could believe that hunting was legal in our Town, located in the most densely populated county in FL! After engaging with FWC, they suggested that the best means to address this concern would be to request that our Town become a designated "Bird Sanctuary" or "Restricted Hunting Area". This has been done in other areas across the state of FL, including in the coastal communities of Manatee and Sarasota Counties (as detailed on the maps of "Designated Bird Sanctuaries" by FWC). In fact, there is already an established Bird Sanctuary called "Boca Ciega Bay" directly across the ICW from our Town, which includes Millenium Park! Our "Bird Sanctuary" designation would reinforce the existing one across the ICW, helping to protect residents, visitors, and wildlife. We are truly blessed to live in such an amazing place! On a daily basis, the beaches of Redington Shores are filled with Black Skimmers and American Oystercatchers (both of which are designated as "state threatened"). There are only two black skimmer colonies on Pinellas County beaches and we are fortunate enough to have one of them! We also have residents and visitors using our ICW on a daily basis for kayaking, paddleboarding, and many recreational watersports. Given all of these factors, designating our Town a "Bird Sanctuary" seems like a sensible thing to do. Whether you agree or not, I would love to hear from you on this important topic - please call or email me to share your thoughts!

**"Be the change that you wish to see in the world."** ... This quote by Mahatma Gandhi is reflective of how I would like to partner with all of the residents of Redington Shores. I encourage everyone to get involved, attend meetings, and let your voice be heard! If you want to make a difference, take an active role or engage with people who do! There are a number of upcoming important initiatives that the Town is working on and I would love to get your input!... Light Pollution, Variance Costs, FEMA programs, updates to the Land Development Code and the Town Charter, just to name a few.
