a. **ADOPTION OF TENTATIVE MILLAGE RATE**

Interim Town Manager Carey explained that each year the Town is required to set an ad valorem millage rate, an important step in the budget process. The Town must also hold 2 public hearings for the millage rate and budget. Those dates are set for: September 3 and 15 at 6:00 pm. The final millage rate cannot exceed the tentatively adopted millage rate but can be lower. Staff recommended the Town Commission confirm the tentative millage rate at 1.6896 mills.

Vice Mayor Schoos moved to approve to set the proposed, tentative Millage Rate at 1.6896 mills, seconded by Commissioner Maynard.

Discussion: Commissioner Hoyt described a press conference by Governor DeSantis that discussed the Florida millage rate. She explained that as property values go up, the millage rate should go down to decrease taxes. She added that as property values are going up, collected taxes are also increasing.

Vote taken: All yea 5 to 0.
