## Vice Mayor Holmes, Commissioner District No 4

There were 3 non-emergency calls, 6 emergency calls; 7 non emergency and 23 EMS calls, all within the approved response time. There will be a Hurricane Expo at the Seminole Fire Recreation Complex on Saturday, May 16 from 10:00 a.m. until 2:00 p.m.

The Town's Hurricane Meeting will be May 28 at 7:00 p.m. Refreshments will be served.

## Commissioner Kapper, Commissioner District No1

The ISO report is due, and rates the Building Department, which has a 3 rating in a scale of 1-9. In the previous year there were 603 permits issued, and 818 inspections performed, with \$225,000 collected in building fees, and \$146,000 in other fees. In the month of April the Town had 64 permits, 1 new single family home, and permit fees at \$24,453.16.

There have been problems with planting the front of the Town Hall building; so the decision was made to put down artificial grass.

#### Commissioner Branch, Commissioner District No 2

Criminal reports were down in Indian Shores and Redington Shores. Traffic citations were down in Indian Shores, but up in Redington Shores. Physical arrests were down in Indian Shores, up in Redington Shores.

#### Commissioner Henderson, Commissioner District No 3

It is turtle nesting season, and the patrols are in force. Commissioner Henderson and Steve Andrews have been going over the plans for the front lot at La Vistana II, and should be ready by June or July. Also, be cautious when crossing Gulf Blvd.
