COMMISSION REPORTS

Mayor Adams

Mayor Adams send his regards to Commissioner Branch as he is not feeling well and wishes him a speedy recovery. Mayor Adams at this time gave the Police Report for Commissioner Branch.

Indian Shores Police Department – Criminal reports, physical arrests and Ordinance violations were up from last year and traffic citations, parking tickets and traffic warnings were down. Mayor Adams reported there has been an epidemic of car break-ins through out the county, including Redington Shores. Mayor Adams encouraged all residents to lock their cars.

Mayor Adams reported the town is aware there is a coyote in town. The town has contacted Pinellas County Animal Control and Fish and Wildlife; neither come out to trap the coyote. Mayor Adams encouraged all to watch their small pets and to leave the animal alone.

Mayor Adams announced the Annual Tree Lighting will be held on Sunday, December 6th at Del Bello Park from 5:00 p.m. to 7:00 p.m. and the annual Santa Parade will be December 12th starting at Town Hall at approximately 3:00 p.m.

Vice Mayor Holmes, Commissioner District No 4

Fire Services – there were no non emergencies reported for the month and there were two emergency calls with an average response time of seven minutes and twenty-three seconds.

Medical Services – there were eight non emergency calls with an average response time of five minutes and fourteen seconds and eighteen emergency calls with an average response time of five minutes and forty seconds.

Vice Mayor Holmes reported the PPI Committee has met. Their first meeting was a very productive meeting, with lots of ideas on Public Outreach and hopefully help with our CRS rating and lowering the rates for our residents flood insurance.

Building Department – there were 87 permits issued in October, with a total revenue of \$11,207.43.
