COMMISSION REPORTS

Mayor Armstrong

Mayor Armstrong thanked everyone who attended the Annual Tree Lighting and also thank you to Chef Tom of Salt Rock Grille and the Blessed Sacrament Choir. Reminder of the Santa Parade on Saturday, December 15, from 3:00 p.m. - 5:00 p.m. and the Holiday Lighted Boat Parade, Sunday, December 16, starting at 5:45 p.m., north of the Madeira Beach bridge heading north through the water ending at the Pub in Indian Shores.

Visitor and Convention Bureau is heavily promoting tourism with a new educational promo for the residents of Pinellas County on the importance of tourism. Without tourism, many businesses would close and jobs lost.

Vice Mayor Adams, Commissioner District No 1

Indian Shores Police Department – all categories are down. Vice Mayor Adams reflected on a story from 23years ago from when he was working for the Tampa Police Department.
