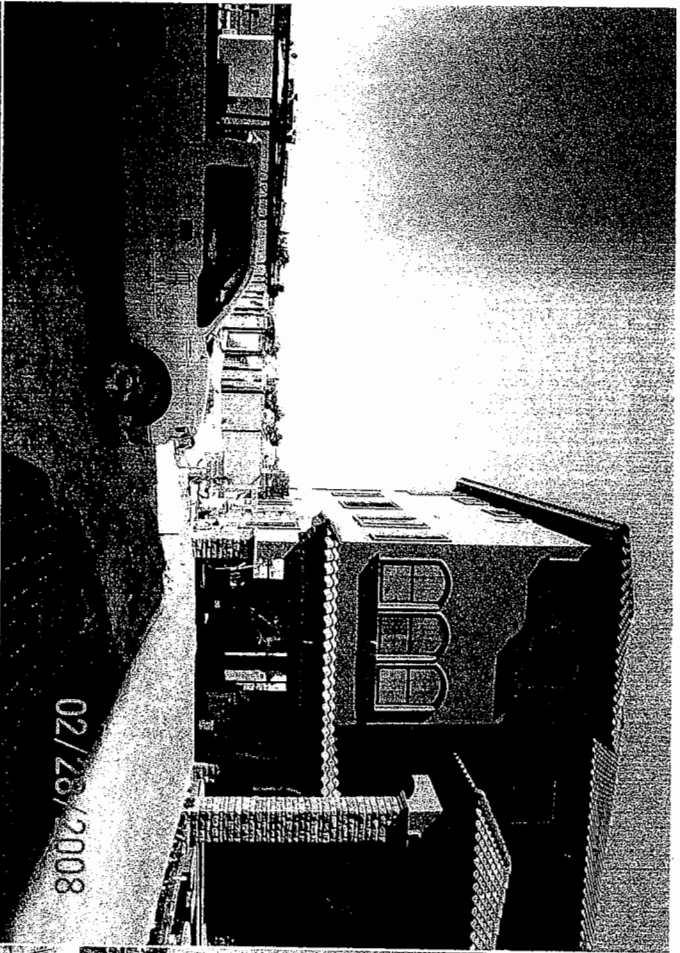

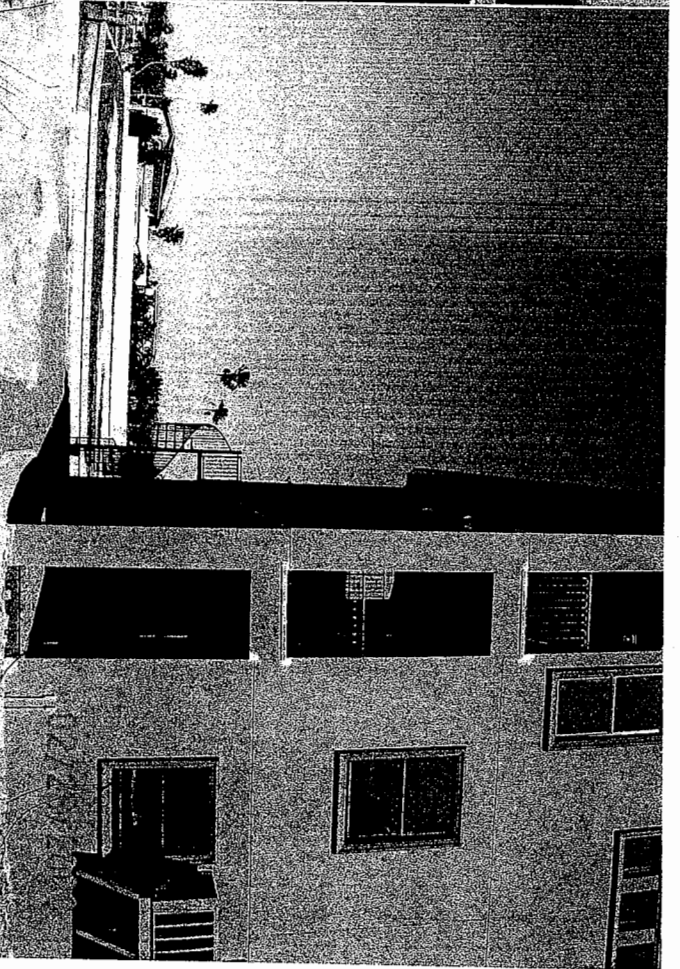

LEFT SIDE VIEW

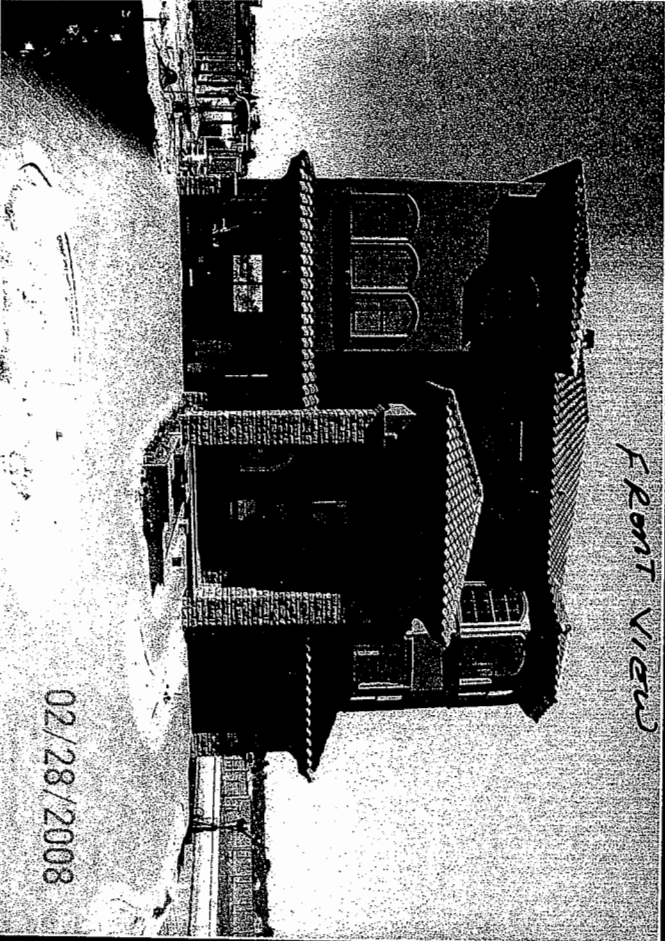

REAR VIEW

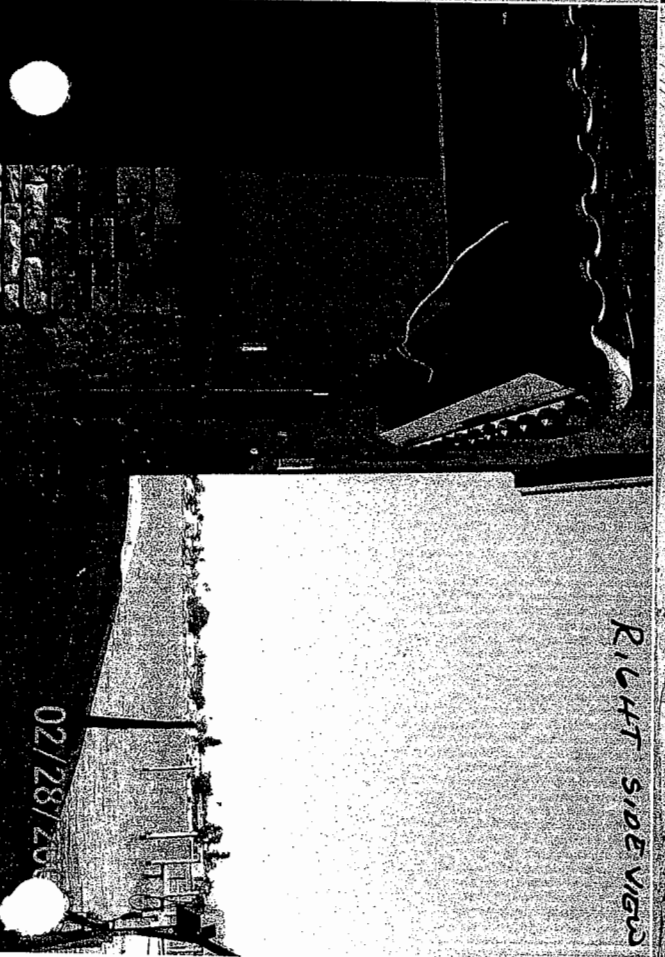


FRONT VIEW
