Present upon roll call: Commissioner Robinson, Commissioner Drumm, Commissioner Neal, Vice Mayor Kapper, Mayor Henderson.

OLD BUSINESS

Update on Check Valves

Commissioner Drumm explained that the City of Madeira Beach has installed the check valves and is having a few issues with them. They are working with Duel and Associates Engineering to rectify the issues, which at this time seem to be sealant issues and residents/landscapers sweeping or blowing yard debris into the street, which become lodged in the storm drains. Commissioner Drumm recommends on waiting to purchase the valves until the final outcome of the findings is released.

Discussion Town Parking Lot - 178th Ave. West and Gulf Blvd., - Parking by Permit

Commissioner Neal stated this subject has been tossed around for three to four months and would like to try something on a temporary basis and is open to any suggestions. On weekends and holidays the parking lot fills up with non-resident vehicles for beach parking. The parking lot was intended for residents to go to the beach, etc. A lengthy discussion followed with ideas of parking by permit only on weekends and holidays, parking by permit only seven days a week or metered parking. This lot was metered before and the meter was removed and placed at the county beach access. The consensus of the Commission is to try on a temporary basis limiting parking by permit only, seven days a week with a limited time.

Discussion - Tentative FY 18/19 Budget

Commissioner Robinson asked for any comments on the budget. None were brought forward. Commissioner Robinson stated the final hearing for the budget will be held, September 10th and 18th at 5:15 p.m.

NEW BUSINESS

Discussion – Resident Request – No Wake Zone in Cove by Sea Breeze

Residents, Denise & Don Vought addressed the Commission with the concern of life safety and animal life safety in this cove and is asking the Commission to mark this code as an entire no wake area. Town Clerk Palmer stated the Town already has permits from FWC for Idle Speed No Wake at the entrance of the cove and also some in the cove along with resume normal safe operation. The Commission was in consensus to apply to have the entire cove a no wake area. Town Clerk Palmer has placed a call into the FWC and will report to the Commission on the matter.

MISCELLANEOUS

Resident, Tim Nachman asked when the underground will be starting. Mayor Henderson stated she has a meeting with Duke Energy tomorrow and should know more.
