## **COMMISSION REPORTS**

#### Mayor Henderson

Mayor Henderson mentioned the Red Tide is still south of the town and hopes as all hope it does not move toward the north and the Pinellas beaches. Resident, Tim Nachman stated he received an email from FWC right before he came to the meeting and the it is now moving south.

Undergrounding Gulf Blvd. – latest we have heard is the start of the project is now projected to start in October/November as there has been a delay with the permitting from FDOT.

Mayor Henderson reminded everyone the town picnic is October 13<sup>th</sup>. The Parks and Recreation committee will be meeting to start planning events for the picnic. Mayor Henderson encouraged all to attend the meeting if they would like to.

Mayor Henderson introduced Nicki McCraney the town's new Deputy Town Clerk. Mrs. McCraney addressed the Commission thanking them for the opportunity and expressed how happy she is to work for the town, as she was raised in Redington Shores and her grandfather was a Commissioner of the town back in the 1980's and her mother was on the Financial Advisory Board years ago.

## Commissioner Neal, Commissioner District No2

Sewer Rehab – the relining and manhole repairs will be continuing in the District Two area, trucks and equipment will be arriving this week. Commissioner Neal told the Commission he reached out to Pinellas County Commissioner Beyrouti in regard to the high sewer treatment bills. Commissioner Beyrouti put him in touch with Mr. Jorgensen and it appears a bracket was rusted by the main meter which was causing the meter to vibrate. The town will be getting credit for over billing and also county staff will be working with the town's daily reading to determine if more money is owed to the Town. The Town is also working with the county to place a meter on our side for another reading before going into the main lift station, so there will be two different readings.

Veterans Park – the benches, bike rack and plaque have been ordered. In the near future a dedication ceremony will take place.

## Commissioner Robinson, Commissioner District No 3

Commissioner Robinson stated the beach renourishment is going along as planned. Those who have already have the renourishment completed are very happy as the sand is being strained to keep the rocks, etc., off the beach.
