Re: FDOT Enhanced Law Enforcement Engagement Challenge (ELEE)

From April to August 2022 the Indian Shores/Redington Shores Police Department participated in an Enhanced Law Enforcement Engagement (ELEE) in FDOT District 7 which encompasses Hillsborough and Pinellas Counties. This engagement program focused on traffic enforcement on FDOT roadways within the district, and our Agency was specifically directed toward enhanced enforcement efforts along Gulf Blvd within our jurisdictions. Twenty-one (21) agencies, both large and small, from both counties participated in this engagement in the district.

On October 27, 2022, FDOT held an awards ceremony and recognized the top performing agencies. The Indian Shores Police Department was ranked 5<sup>th</sup> overall Law Enforcement agency among agencies like Tampa PD, Pinellas County Sheriff's Office, and St. Petersburg PD.

As a result of our officers' efforts, and or 5<sup>th</sup> place ranking, the ISPD was awarded the below listed equipment from FDOT that is valued at \$16,000.00. This new equipment will be used to enhance our traffic safety efforts in Indian Shores and Redington Shores going forward.

This is a significant accomplishment, especially given the size of our agency, and all ISPD Officers should be commended for their efforts. The ISPD looks forward to participating in these type of Traffic Safety engagements in the future.





Re: Life Saving Commendation(s)

During the Redington Shores Commission Meeting on September 14, 2022, former Commissioner Jeff Neal (Jeff) collapsed in his chair and suffered a massive heart event and was in full cardiac arrest. His heart had stopped beating and he was not breathing. Jeff was laid on the floor so we could assess the seriousness of the situation.

Redington Shores citizens, Mr. Richard (Rich) Perez, and Dr. Marek Stobnicki (Merek), and his wife, Dr. Ola Stobnicki were in the audience, attending the meeting. Rich Perez, and Marek immediately moved in and assisted Major Glen Smith and me in clearing Jeff's airway in preparation of performing CPR. We retrieved and activated the Town's AED. Following one shock from the AED, Jeff's heartbeat and breathing was restored. We monitored Jeff's heartbeat (with the AED) and his breathing until paramedics arrived.

We continued to assist Madiera Beach (MBFR) and Pinellas Suncoast Fire Rescue (PSCFR) ALS units as they attached their AED and other equipment and started an intravenous line with medication. Jeff went into cardiac arrest several more times and paramedics had to administer (3) additional shocks from their AED in order to stabilize him enough to be transported to a hospital.

Everyone involved worked cohesively as one professional group focused on the mission of doing whatever we could to save Jeff's life. There were no politics, no opinions, no likes, or dislikes, no egos, or power struggles; just people helping each other in a time of crisis. The actions initiated that night resulted in Jeff Neal being revived and his heartbeat and breathing being stabilized within minutes. As a result, Jeff did not sustain serious effects and I am thankful to say that Jeff Neal is still with us and on the road to recovery.

Both fire companies and the personnel that arrived from PSFR and MBFR worked together professionally and with great urgency and are to be commended for the extensive work performed to save Jeff Neal's Life.

This is an example of people at their finest in a dire situation.
