## **AN ORDINANCE OF THE TOWN OF REDINGTON SHORES AMENDING THE TOWN CHARTER**

Every 10 years, the Town of Redington Shores appoints a **Charter Review Committee** to review and make recommendations for changes to our Town Charter. In April 2024, the Town appointed a Charter Review Committee that met several times to review our current charter. This committee then brought their recommendations to the Commission as 2024-04 that outlined each proposed amendment. These recommendations will be brought before the residents of Redington Shores as 16 individual Referendum Questions on the March 11, 2025 ballot..
