

# BOARD OF COMMISSIONERS TOWN OF REDINGTON SHORES BUDGET WORKSHOP MEETING WEDNESDAY, JUNE 25, 2025

## **MINUTES**

A **Budget Meeting** of the Board of Commissioners of the Town of Redington Shores, Florida, was convened at 6:01 p.m.

#### A. ROLE CALL

#### **B. NEW BUSINESS**

1. Accountant – FY26 Draft Budget Discussion Accountant Heather Guadagnoli explained the documents provided in her financial analysis starting with the millage rate and estimate of taxable value. She explained that property values were down 1.02%, and as such, she would recommend keeping the millage rate the same. She informed that the option to raise or decrease the millage rate will be decided by the commission at the July 23, 2025, meeting.

#### C. OLD BUSINESS

- 1. Updated Policy Goals and Objectives FY25/26 document Administrator Carey reviewed the updated target dates for all projects and noted the updates were made to the goals and objectives documents. There were no questions about the updates.
- 2. Updated Capital Improvement Plan document
  Administrator Carey noted she had updated the capital improvement plan. She stated she had applied for 2 HMGP
  grants and had attended an LMS meeting earlier in the day. Both the stormwater infrastructure and utility
  undergrounding projects ranked favorably in the preliminary ranking. The potential \$2.5 million grant for Helene and
  \$1.6 million grant would come from HMGP grants and final voting will occur in July. Commissioner Hoyt thanked
  Administrator Carey for sourcing the grants and applying for them.
